**Private Swimming Pool Safety Requirements**  
**Notice of Requirements**

I (We) acknowledge that a new swimming pool, spa or hot tub will be constructed or installed at the above address, and hereby affirm that one of the following methods will be used to meet the requirements of Chapter 515 of the Florida Statutes.

- Please initial the method(s) to be used for your pool, spa or hot tub -

\_\_\_\_\_ The pool will be equipped with an approved safety pool cover that complies with ASTM F1346 (Standard Performance Specifications for Safety Covers for Swimming Pools, Spas and Hot Tubs)  
*Attach manufacturer's product compliance information.*

\_\_\_\_\_ A continuous one-piece barrier (child fence, screen enclosure or fence) meeting the requirements of FBC R4501.17 will protect the pool perimeter. Submit plans indicating the type and location of the barrier. For a child fence specify the location of the end that is not removable without the use of tools.

*Attach manufacturer's product compliance information.*

\_\_\_\_\_ A combination of dwelling walls and/or non-dwelling barriers (screen enclosure, fences, etc.) will protect the pool perimeter. Submit plans specifying type and location of all non-dwelling barriers.  
*Attach manufacturer's product compliance information.*

\_\_\_\_\_ Any combination of protection which incorporates dwelling walls and doors/windows opening directly into the pool perimeter, which includes self-closing, self-latching devices, and/or exit alarms complying with UL2017 and FBC R4501.17.1.9. Submit plans showing location and type of all openings and specifying type of hardware or exit alarm to be used at each location for perimeter protection.

\_\_\_\_\_ A swimming pool alarm that, when placed in a pool, sounds an alarm upon detection of an accidental or unauthorized entrance into the water. Such pool alarm must meet and be independently certified to ASTM F2208, titled "Standard Safety Specification for Residential Pool Alarms," which includes surface motion, pressure, sonar, laser and infrared alarms. For purposes of this paragraph, the term "swimming pool alarm" does not include any swimming protection alarm device designed for individual use, such as an alarm attached to a child that sounds when the child exceeds a certain distance or becomes submerged in water.

*Attach manufacturer's product compliance information.*

**I understand that not having one of the above installed will constitute a violation of Chapter 515, F.S. and will be considered as committing a misdemeanor of the second degree, punishable by as provided in section 775.082 or 775.083 F.S.**
