NEW RESIDENTIAL, DUPLEX & TOWNHOUSE CHECKLIST

- BROWARD COUNTY UNIFORM BUILDING APPLICATION PER DISCIPLINE (STRUCTURAL, ROOF, PLUMBING, ELECTRICAL, MECHANICAL, FIRE SPRINKLERS, ETC)**
(TOWNHOUSES / DUPLEX – APPLICATIONS FOR ALL DISCIPLINES FOR EACH UNIT)

OTHER SUB PERMITS SUCH A ROOFING, GAS, SPRINKLERS, LOW VOLTAGE, ETC MAY BE SUBMITTED AT A LATER DATE.

- CONTRACTOR RECORDS UP-TO-DATE**
- OWNER/BUILDER AFFIDAVIT (IF OWNER TO ACT AS CONTRACTOR)**
- RECORDED NOTICE OF COMMENCEMENT (IF JOB VALUE OVER \$2,500) FBC CHAPTER ONE, BROWARD COUNTY ADMINISTRATIVE PROVISIONS 105.8 – MUST BE RECORDED & POSTED PRIOR TO THE FIRST INSPECTION**
(TOWNHOUSES / DUPLEX -NEEDED FOR EACH UNIT)
- 2 SURVEYS**
- 2 SITE PLANS**
- 2 SETS OF PLANS (SIGNED & SEALED IF OVER \$10,000)**
- 2 COPIES OF STRUCTURAL CALCULATIONS**
(TOWNHOUSES / DUPLEX -NEEDED FOR EACH UNIT)
- BROWARD COUNTY SPECIAL INSPECTORS FORM**

- 2 SETS OF TRUSS DRAWINGS (SUBMITTED PRIOR TO RECEIVING A FOUNDATION INSPECTION)**
 - APPROVAL FROM BROWARD COUNTY ENVIRONMENTAL PROTECTION & GROWTH MANAGEMENT DEPARTMENT (TOWNHOUSES/DUPLEX – REQUIRED FOR EACH UNIT)**
 - 2 COPIES OF ENERGY CALCULATION FORMS, HEATING/COOLING LOAD CALCS, MANUFACTURER SPECS (TOWNHOUSES / DUPLEX -NEEDED FOR EACH UNIT)**
 - 2 COPIES OF PRODUCT APPROVALS**
 - 2 COPIES OF SHOP DRAWINGS (SIGNED & SEALED & APPROVED BY THE DESIGNER OF RECORD)**
- *REQUIRED FOR STAIRS, RAILINGS, SCREEN ENCLOSURES, OR ANY OTHER APPLICABLE SPECIAL CONSTRUCTION**
- FOR PINETREE & RANCHES, NEED A COPY OF SEPTIC & WELL PERMITS FROM BROWARD COUNTY HEALTH DEPARTMENT, AND DRAINAGE INFORMATION ON SURVEY.**
 - COPY OF RECEIPT FROM BROWARD COUNTY FOR SCHOOL & ROAD IMPACT FEES**
 - A PARK FEE OF \$3,850 WILL BE INCLUDED WITH THE PERMIT FEE.**
 - TREE REMOVAL PERMIT WILL BE REQUIRED IF TREES ARE LOCATED WITHIN THE SLAB AREA.**
 - COPY OF SIGNED CONTRACT BETWEEN CONTRACTOR & OWNER**
 - TO PICKUP PERMIT, MUST SUBMIT WATER METER RECEIPT, EXCLUDING PINETREE AND RANCHES IF SERVICED BY SEPTIC AND WELL.***
