TEMPORARY EASEMENT FOR CONSTRUCTION ACCESS

THIS EASEMENT AGREEMENT IS GIVEN THIS ____ DAY OF _____, 201____, BY
_____, ("GRANTOR"), WHOSE MAILING ADDRESS IS HEREIN, THE TERM
"GRANTOR" SHALL INCLUDE ANY AND ALL HEIRS, SUCCESSOR OR ASSIGNS OF THE
GRANTOR, AND ALL SUBSEQUENT OWNERS OF THE "PROPERTY" (AS HEREINAFTER
DEFINED) AND THE TERM "GRANTEE" SHALL INCLUDE ANY SUCCESSOR OR ASSIGNEE OF
GRANTEE.

WITNESSETH

WHEREAS, GRANTOR IS THE FEE SIMPLE OWNER OF CERTAIN LANDS SITUATED IN
_____ COUNTY, FLORIDA, AND MORE SPECIFICALLY DESCRIBED IN EXHIBIT
"A" ATTACHED HERETO AND INCORPORATED HEREIN (THE "PROPERTY"), WHICH IS
LOCATED AT _____ [INSERT ADDRESS OF PERMITTED SITE];

AND

WHEREAS, GRANTOR HAS AGREED TO GRANT AND CONVEY TO GRANTEE, A TEMPORARY
NON-EXCLUSIVE ACCESS EASEMENT OVER, ON, UNDER, UPON, AND ACROSS THE PROPERTY
FOR THE SPECIFIC AND LIMITED PURPOSES SET FORTH HEREIN.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS, PROMISES, TERMS
AND CONDITIONS SET FORTH HEREIN, TOGETHER WITH OTHER GOOD AND VALUABLE
CONSIDERATION PROVIDED TO GRANTOR, THE ADEQUECY AND RECEIPT OF WHICH ARE
HEREBY ACKNOWLEDGED, GRANTOR HEREBY VOLUNTARILY GRANTS, CREATES, CONVEYS,
AND ESTABLISHES A TEMPORARY EASEMENT FOR AND IN FAVOR OF GRANTEE UPON THE
PROPERTY DESCRIBED ON EXHIBIT "A" WHICH SHALL RUN WITH THE LAND AND BE
BINDING UPON THE GRANTOR, AND SHALL REMAIN IN FULL FORCE AND EFFECT FOR THE
DURATION PROVIDED BELOW.

THE SCOPE, NATURE, AND CHARACTER OF THIS EASEMENT SHALL BE AS FOLLOWS:

1. RECITALS: THE RECITALS HEREIN ARE TRUE AND CORRECT AND ARE HEREBY INCORPORATED INTO AND MADE A PART OF THIS EASEMENT.
2. PURPOSE: IT IS THE PURPOSE OF THIS EASEMENT TO GRANT TEMPORARY NON-EXCLUSIVE ACCESS EASEMENT OVER, ON, UNDER, UPON, AND ACROSS THE PROPERTY AT ALL TIMES TO PERFORM ALL ACTS NECESSARY TO ENSURE FULFILLMENT OF ALL REQUIREMENTS OF _____ [PERMIT NUMBER], ALL OF WHICH GRANTEE SHALL BE AUTHORIZED TO PERFORM IN ITS SOLE DISCRETION.
3. NO DEDICATION: NO RIGHT OF ACCESS BY THE GENERAL PUBLIC TO ANY PORTION OF THE PROPERTY IS CONVEYED BY THIS EASEMENT.
4. GRANTEE'S LIABILITY: GRANTEE'S LIABILITY IS LIMITED AS PROVIDED IN SUBSECTION 704.06(10) AND SECTION 768.28, F.S. ADDITIONALLY, GRANTEE SHALL BE RESPONSIBLE FOR ANY COSTS OR LIABILITIES RELATED TO THE OPERATION, UPKEEP, OR MAINTENANCE OF THIS EASEMENT. GRANTEE SHALL RESTORE CONDITION OF EASEMENT TO "AS RECEIVED" CONDITION UPON RETURN TO THE GRANTOR.
5. DURATION: THIS EASEMENT SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL THE REQUIREMENTS OF _____ [PERMIT NUMBER] THAT RELATE TO THE PROPERTY ARE SUCCESSFULLY COMPLETED (AS INDICATED IN WRITING BY GRANTEE) OR WITHIN 1 YEAR FROM THE DATE THIS EASEMENT IS RECORDED (WHICHEVER DATE IS EARLIER), UNLESS OTHERWISE EXTENDED IN WRITING BY THE GRANTOR AND GRANTEE. THIS EASEMENT MAY BE AMENDED, ALTERED, RELEASED OR REVOKED ONLY BY WRITTEN AGREEMENT BETWEEN THE PARTIES HERETO OR THEIR HEIRS, ASSIGNS OR SUCCESSORS-IN-INTEREST, WHICH SHALL BE FILED IN THE PUBLIC RECORDS IN CITY OF PARKLAND, FL.
