- All vendors must provide a current DBPR License
- All vendors subject to a fire inspection prior to serving
- The City reserves the right to deny any application
- No setup will be allowed after official load-in times
- Vendors must stay for remainder of event time
- Vendors must provide their own 10x10 tent for setup

APPLICATION DEADLINE:

Applications must be received no later than January 31, 2023. Late or incomplete applications will not be accepted. Payment is due at the time of application and can be made by check or money order payable to "City of Parkland." Credit card payments can be arranged by request via e-mail.
