Program Details and Requirements

- Applications for Gold Certification: require compliance achieving 100 points based on the chart on reverse side.
- Applications for Silver Certification: require compliance achieving 75 points based on the chart on reverse side.
- No person or entity will be eligible for an award unless he/she has fully completed the application and requirements as approved by the City Manager.
- Certification is good for two years from time of award at which time a re-certification application is required.
- Required inspections will be scheduled no later than four weeks from the application sufficiency and required to take place during the hours of 8:00 am – 5:00 pm, Monday – Friday excluding City holidays.
- By submitting this application the business owner is allowing the City to inspect and verify program compliance with a scheduled inspection.
- All back up and support documentation is subject to public record requests.

Certified Green Business Criteria Points

Cat 1 - Water Conservation

- 15% Decrease in indoor and outdoor water use through the adoption of more efficient products and practices. **15 points.**
- Help tenants make water-efficient choices, including differentiating between products and services and adopting simple daily activities that reduce 10% of the overall water use. **10 points.**
- Encourage innovation in the manufacturing and sale of water conservation products with 5% of the tenants participation. **5 points.**
- Establish and standardize criteria that ensure water conservation products efficiency, performance, and quality providing a 15% decrease in water use. **15 points.**
- Realize and promote water savings on a local level. **5 points.**
- Provide measurable water savings results of 5%-10%. **10 points.**
- Achieve water efficiency through several technology options (3 or more). **15 points.**
- Obtain independent, third-party certification, SFWMD WaterSense. **10 points.**

Cat 2 - Using Green products

- Green alternative products - Using eco products made from recycled material, products that are more respectful of the environment. **15 points.**
- Green energy store - Lease to an appliance store that sells solar powered water heaters or energy-star certified kitchen appliances? Maybe a website that offers information and sells all types of CFL, LED and energy efficient light bulbs. **25 points.**

- Green transportation – Business that use vehicles with alternative fuel sources. **20 points.**

Cat 3 - Energy Conservation

- 5% Decrease in kilowatt-hour usage over a 6 month period = **5 points.**
- 10% Decrease in kilowatt-hour usage over a 6 month period = **10 points.**
- 15% Decrease in kilowatt-hour usage over a 6 month period = **15 points.**
- 20% Decrease in kilowatt-hour usage over a 6 month period = **20 points.**

Cat 4 – Recycling

- 5% Decrease in monthly waste disposal costs over a 6 month period = **5 points.**
- 10% Decrease in monthly waste disposal costs over a 6 month period = **10 points.**
- 15% Decrease in monthly waste disposal costs over a 6 month period = **15 points.**
- 20% Decrease in monthly waste disposal costs over a 6 month period = **20 points.**

Cat 5 – Building a Green Business

- Promoting water conservation to tenants or customers. **10 points.**
- Promoting energy conservation to tenants or customers. **10 points.**
- Promoting recycling to tenants or customers. **10 points.**
- Promoting the use of green products to tenants or customers. **10 points.**
