We are excited to bring back Parkland Day and would like to invite you to join us in our parade as we celebrate our 60<sup>th</sup> Anniversary.

**EVENT:** Parkland Day 2023 Parade

**DATE:** Saturday, March 11, 2023

**TIME:** 10:00 am (Staging for parade participants starts at 8:00 am)

**ROUTE:** Starts at the corner of Pine Island and Nob Hill Rd; Proceeds south on Pine Island to Trails End; Proceeds east on Trails End to Pine Trails Park entrance.

**THEME:** 60 and Sensational

Entries will be judged so be sure to decorate in this year's theme "60 and Sensational". As your unit passes our reviewing stand and judges, we would like to make a brief announcement about your group, organization, or business. With this in mind, we ask that you attach a short paragraph to announce about your entry. Please remember to keep moving as stopping along the parade route is not permitted. All winners will be announced that evening on the stage during the main event (approximately around 7 pm) at Pine Trails Park.

#### PARADE RULES:

- All entries must provide a positive and desirable image to the community.
- All entries, including any floats and signage, must be non-political and non-partisan. No entries will be accepted from political organizations.
- Entries must not create a conflict of interest for the City of Parkland.
- The City reserves the right to deny any application.
- No throwing or distribution of items or handouts before, during or after parade; including election campaign materials.
- All vehicles must be properly registered and insured (must provide current registration and insurance with application).
- All vehicle lights must be fully operational.
- Driver of vehicle must be 18 years or older (must provide copy of license with application).
- Floats / vehicles must not exceed 55 feet in length.
- Clearance of 12 inches from ground must be kept from frame. No items should drag along roadway.

- Props on float should not exceed 12 feet in height or width.
- Float platforms must be steady and capable of carrying the weight imposed upon it.
- Decorative material must be structurally sound and should not pollute roadways.
- All participants must keep moving. Do not stop along parade route.
- Participants may not jump on/off vehicle during the parade.
- If music or amplified sound will be part of your entry, notification must be given on application. Music or performance must maintain a volume that does not obstruct or interfere with other participating parade entries.
- Horses will be allowed in parade; however, they must be accompanied by a pooper scooper.
- Golf carts will be allowed in parade.
- All parade operators must attend the safety meeting held prior to parade in order to participate.
- All accepted applicants will be notified by the third week of February of staging location, directions, and times for set up. Additionally, applicants will be notified at that time of the required safety meeting location, date and time.
- Car pooling is encouraged for those participating. Parking for vehicles not driving in parade will be available at the north end of Pine Trails Park (by fields 6-9).

#### APPLICATION DEADLINE:

Applications must be received no later than January 31, 2023. Late or incomplete applications will not be accepted. Payment is due at the time of application and can be made by check or money order payable to "City of Parkland." Credit card payments can be arranged by request via e-mail.

Participant understands that this Release and Waiver is intended to be as broad and inclusive as permitted by the laws of the state of Florida and agrees that if any clause or provision of this Release and Waiver shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not affect the remaining provisions of this Release and Waiver.
